- i. The first named Trustees i.e., Dr. Aravind V. Patil and Dr. Mrs. Vidya Aravind Patil shall be Trustees for life and Dr. Aravind V. Patil shall be the Chairman of the Board of Trustees. All the other Trustees normally will hold office for three years. However, the first named Trustees may at any time without assigning any reason reconstitute the Board of Trustees.
- ii. After the lifetime of the first Trustees he / she shall be replaced by his / her ELDEST MALE / FEMALE SUCCESSOR who will hold office for lifetime and so on. In the event a minor till becomes major, the affairs of the trust shall be administered by other trustees by electing the Managing Trustees among themselves till minor attains majority. In case of special circumstances the powers obtained to the elected Managing Trustee shall be relinquished and the successor shall act in accordance with the test of this Trust deed.
- iii. As stated, the trustees other than the first Trustees (life time Trustees) of Trust will hold office, subject to these presents, for a period of three years from the date of their appointment but will be eligible for reappointment.
- iv. Notwithstanding what has been stated in this clause, any of the Trustees may retire after giving a calender month's notice in writing of his intention to do so to each of the other Trustees for the time being and upon the determination of such month, the Trustees giving such notice shall ipso-facto cease to be the Trustees of the trust.
- v. The Board of Trustees shall consist of a minimum number of two and maximum number of seven Trustees.
- vi. The decision of the Board of Trustees shall be taken by majority. If there is an equal division the chairman will have a casting vote.

8. Without prejudice to the generality of the powers, the Board of Trustees shall have the following powers.

- To employ Professors, visiting Professors, Consultants, Teachers, Clerks and other employees etc., on permanent / temporary basis, agent bankers, accountants and other on such remuneration as they may think fit. To appoint advocates, attorneys and to execute power of attorneys etc., and on behalf of the trust.
- To delegate any powers as they can lawfully delegate to any other personal to execute such power as they may think fit for the purpose.
- To convert, to call in to sell or otherwise dispose of any of the investments comprised in the trust property and invest or change the nature of any other investment contained, therein, to compound and settle any claims against the trust.
- To invest trust moneys in fixed deposits with Nationalised Banks, Government securities or any other investments as provided for in section 11 (5) of the Income Tax Act 1961.
- To withdraw any power or revoke any appointment of any employee or attorney.
- To sell any immovable property belonging to the Trustee.
- To let any portion of any immovable property forming part of the Trust Fund, at such rent and for such period and on such terms and conditions as they may think fit and accept surrender any lease.
- To maintain Bank accounts in the name of the Trust. And the chairman to operate and said account.
- To appoint proxy or proxies for voting at any meeting of creditors, contributors, contributories, shareholders or otherwise.

- xi. To accept Gift, Donations, or contributions in so far as they are not inconsistent with the objects of the trust and all such gifts donations and contributions shall form part of the corpus of the trust, unless it is otherwise specifically given in written by the donor.
- xii. To establish trusts and other institutions having similar objects of those of this trust.
- xiii. To acquire and take over immovable and other properties by purchase, lease, gift, license or otherwise.

Provided further that any or all these powers can be exercised by the Chairman of the Board of Trustees by himself or any trustee or any group of term on being do authorized by the BOARD OF TRUSTEES.

9. These powers of the Trustees shall be so exercised as to ensure that the income of the Trustee would be exempt under section 11/10 (22) of the Income tax Act, 1961 as read with section 12, 12A amended from the time to time. It is clarified that the power of investment of the Trust Funds including these mentioned in clause 8(iv) shall be exercised in accordance with the provisions of section 11(5) read with section 13 of the Income tax Act 1961.

10 The Trustees shall keep proper books of accounts of the income and expenditure of the trust, which shall be closed every year on 31st march. They shall be audited by a Chartered Accountant and a Certificate obtained. These shall be in the custody of the Chairman of the Board of Trustees.

11 The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

- 13 A minute book shall be maintained at the office by the board of trustees. Minutes of all meetings, appointments and entry into the office of every new trustee and all other proceedings of the board of trustees shall be entered and recorded in such minutes books and shall be signed by the chairman of the board of trustees of the meeting either at the conclusion thereof at the subsequent meeting when they are duly confirmed.
- 14 The beneficiaries of the trust shall be chosen without regard to caste, creed, community or sex of individual.
- 15 a) The chairman of the board of trustees shall at all times during his continuance in the office, has the right to delegate his powers to any of the remaining trustees or to other attorneys or agents, with the prior consent of the board of trustees.
- b) The present chairman of the board of trustees during his life time and thereafter the Board of Trustees may constitute Management Committees / Advisory councils to run and look after the day to day administration in respect of the various institutions run by the trust. Such committees/ councils will function under the overall control and supervision of the chairman of the board of trustees on such terms and conditions as may be laid down by the board.
- 16 In the event of the determination of trust or dissolution, for any reason, the Trustee shall makes over or transfer the properties of the trust to a charitable institution or a charitable trust having similar objects to those of this trust, enjoying exemption under section 80 G of the Indian Income Tax Act, 1961 with the consent of the Commissioner of Income tax, provided that under no circumstances the properties of the trust at the time of dissolution at any time shall be distributed among the trustees.

17. YEAR OF THE TRUST :

The year of the trust shall be the financial year from 1st APRIL to the 31st MARCH every year.
